

**JAMES KILPATRICK, JAMES VARNER and JIMMIE SNIDER  
MEMORIAL SCHOLARSHIP APPLICATION**

*The following will be the initial criteria to qualify for scholarship funding.*

The President of the Board shall appoint an ETBA member as Chairman of the Scholarship Committee. The Executive Board will select four ETBA members to serve on the Committee. The Chairman and Committee will review applications and recommend the scholarship recipients to the Board of Directors.

The amount of funding available and the number of qualified applicants determines the number of scholarships to be awarded, as well as the amount of each. It is our intent to provide a minimum of \$500 per semester.

The applicant must be the son or daughter of an ETBA member, of which one or both parents must reside in the ETBA jurisdictional area.

The applicant must be a senior in high school or enrolled in a College or University in pursuit of a 4 year degree or in pursuit of a certification from a Technical Institute. Pursuit of education associated with the building or construction industry **is not required**; however, preference will be given to those applicants. An individual recipient's long term accumulated maximum scholarship is limited to \$4000. This is the maximum limit of funding- it is not a guarantee that an applicant will receive the \$1000 scholarship per year for four years.

The applicant will be required to complete a written application and could possibly be asked to attend an oral interview with the scholarship committee.

This is a 1 year (2 semesters) scholarship, beginning with the Fall semester. Each semester will be funded upon proof of enrollment/registration and last semester grades transcript/GPA. A minimum of a 2.50 GPA on a 4.00 scale is required to continue subsequent semesters' funding.

The scholarship committee may amend these minimum requirements at any time upon the approval of the board of directors of the ETBA.

ETBA is a 501(c)(6) non-profit corporation operating under the laws of the State of Texas. Contributions are not tax deductible.

ETBA will accept donations "in memory of" and/or "in honor of" a designated person for the purpose of awarding scholarships. Those funds will be accepted and distributed at the sole discretion of the ETBA Scholarship Committee. When the designated memory/honor funds are less than \$500, the remaining balance will be transferred to the general ETBA scholarship fund- known as the Kilpatrick Scholarship Fund. The ETBA office staff will notify the family by e-mail or mail when the funds no longer meet the minimum requirement to award a scholarship "in memory of" their family member.

The ETBA will be financially responsible for the funds and distribute funds after all criteria have been met and the board of directors has approved the funding.

The above stated criteria will be the initial parameters of this fund and will be subject to final approval within legal limits. In the event, amendments are required; the concept of the James Kilpatrick, James Varner and Jimmie Snider Memorial Scholarship Funds will endure.
